n July 1987, Alan J. Gelenberg, M.D., assumed the editorship of *The Journal of Clinical Psychiatry* and began an association with our company that has been a resounding success. As Publisher, I have been privileged to collaborate with Alan to create a substantive body of literature that has helped you, our readers, better diagnose and treat your patients.

During these past 20 years of Alan's guidance, the *Journal* has grown and prospered. Each issue contains peer-reviewed articles submitted by the world's top researchers that provide the most important clinically relevant and methodologically sound research on the treatment of CNS disorders. Due to the high quality of these articles, today we are the best read* and one of the most often cited† psychiatry journals in the world as evidenced by our impact factor.

Reaching this stature has not only taken an enormous commitment of time and effort, but also required the knowledge and talents of a skilled researcher, teacher, and leader like Alan.

Alan has devoted his career to academic research and teaching. He received his M.D. from the University of Pennsylvania School of Medicine and his psychiatry training at Massachusetts General Hospital. He held academic appointments at Harvard Medical School and the Massachusetts Institute of Technology before becoming Professor and Head of the Department of Psychiatry at the University of Arizona in 1989. He is currently the Chair of the Workgroup on Major Depressive Disorder for the American Psychiatric Association's planned revision of the DSM.
